### Voting By Mail

Ballots will be mailed beginning Monday, April 6, 2020. If your application is received after April 6, 2020, allow 3 to 5 business days for your application to be processed and your ballot to be mailed.

### Ballot Return

Ballots must be returned to the Election Commission or any postage-free drop box location by **8:00 p.m. on Tuesday, May 12, 2020**. Drop boxes will be open from Monday, April 6, 2020 through Tuesday, May 12, 2020 at 8:00 p.m. A list of drop box locations can be found at [www.votedouglascounty.com](http://www.votedouglascounty.com), and the list will be included on the yellow instruction sheet enclosed with your ballot.
